A group of pro-parents choice advocates planned, funded, and executed a counter-protest at the AAP National Conference in San Francisco. We conveyed our appreciation for AAP pediatricians who work tirelessly to keep children healthy. And we expressed our disgust with the anti-circumcision activists who attack the doctors, using vile slurs and vicious intimidation tactics. We believe it was the first organized grass-roots response to the anti-circumcision movement.

#### **REACTION**

The responses from the intactivist community have been predictably vitriolic and boorish. Our adversaries have determined that we are "pro cutters", "dumb and evil", "ignorant", "despicable", "morons", "imbeciles", "maggots", "narcissists", "trolls", "perverts", "pedophiles", and "circumfetishists." Our protest has been judged "pathetic", "weak", a "sorry demonstration", and "human ignorance at it's [sic] lowest point."

Our new website and Facebook page have driven some of the fanatics to anguish. Apparently the delicate snowflakes are unable to cope with having their own misguided views challenged via sober analysis and science-based evidence.

Our adversaries say we lack conviction, "view children as property," and "want baby boys to be sliced up." They complain that we attack their character – while they viciously defame the character of heroic physicians. Meanwhile the executive director of Intact America dismisses us as "insignificant."

#### **MOTIVES**

Our opponents are frantic to vilify anyone who dares to stand up and oppose their harassment of doctors and parents. Our opponents are telling themselves that we were hired by the AAP or by individual doctors and that we were paid \$40 to hold signs produced by the AAP.

We are all volunteers who paid our own transportation, lodging, and meal expenses. Each team member paid for her own T-shirt. Our group, including many who couldn't attend in person, combined resources to cover the cost of the signs, which were printed at an office supply store. No one paid us, no one asked us to protest, and the American Academy of Pediatrics had no knowledge of our plans.

#### RETALIATION

Intactivist aggressors seek to inflict real-life punishment in the form of humiliation and economic harm on anyone who dares to who stand up to them. They juxtapose photos of our anti-bullying signs with pictures of 1950's racists and contemporary homophobes. They accuse us of being "circumfetishists" who view children as property. They say that we are aroused by the act of circumcision or by viewing pre-pubescent genitals. We won't dignify such scurrilous accusations with a response.

Our adversaries are pouring through posts and photos in order to compile a dossier on each of our six sign holders. Threats to expose our identities, inflict physical violence, and harass team members by contacting our employers have been met with the approval of the online mob.

We hold all who collaborate with the bullies responsible for their malicious actions. That includes groups like Intact America that coordinate their events with the bullies.

WE WON'T BE INTIMIDATED. WE WON'T BE SILENCED. WE WON'T BACK DOWN.
THE HARASSMENT OF DOCTORS AND PARENTS MUST END.

Most of the screen shots on the following pages are from public pages and groups.

A few intended for private or limited audiences were sent to us by rational circumcision opponents who are fed up with the bullying behavior and hysteria of the rabid online mob.

Our group clearly stands for parental choice, and none of our sign holders perform circumcisions. Yet James Loewen, a Canadian anti-circumcision propagandist who calls himself an independent documentary photographer, dishonestly identified us in his captions as "pro child cutters."
